Bidding will be conducted through National Competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" *July 2016 revised November 2017, August 2018 and November 2020* ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.

Interested eligible Bidders may obtain further information, from the KISIP Project Procurement Office, Elgon Road, Upper Hill, Nairobi during normal office working hours (0900 to 1700 hours EAT). - 7. All bids should be accompanied with a Bid security in form of a **Bank Guarantee or a Bank Draft issued** by a reputable Bank located in Kenya, or Insurance of 2% (Bid Sum) from a reputable Insurance firm approved by Public Procurement Regulatory Authority (PPRA).
